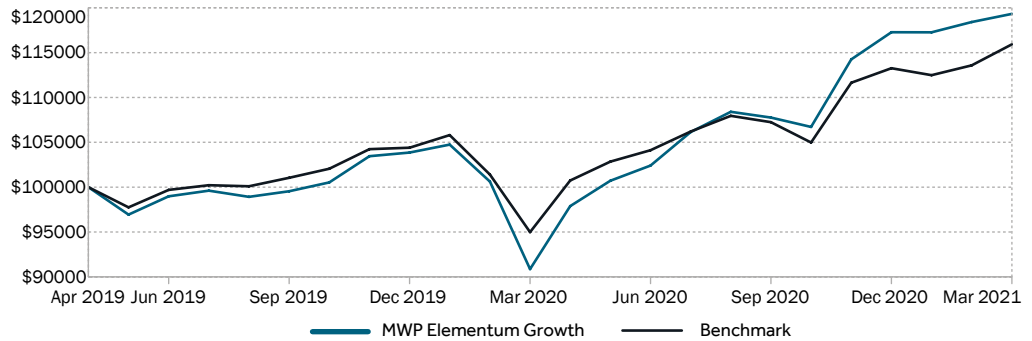

Strategy

The MWP Elementum Growth Portfolio is an evidence-based balanced growth mandate that aims to balance three factors that have been found to be the primary drivers behind risk and return: equity allocation, value versus growth stocks, and small/medium versus large stocks. This portfolio is built in a very cost effective way, with index ETFs at the core and some smaller allocations to active funds or individual stocks on the periphery. The portfolio is rebalanced quarterly, at minimum, with some allowance for tactical shifts, from a minimum of 60% in equities to a maximum of 70%.

Growth of \$100,000



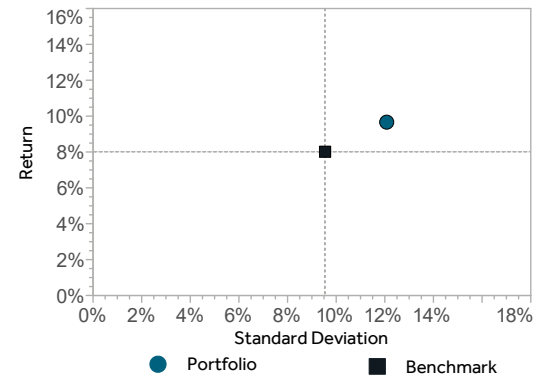

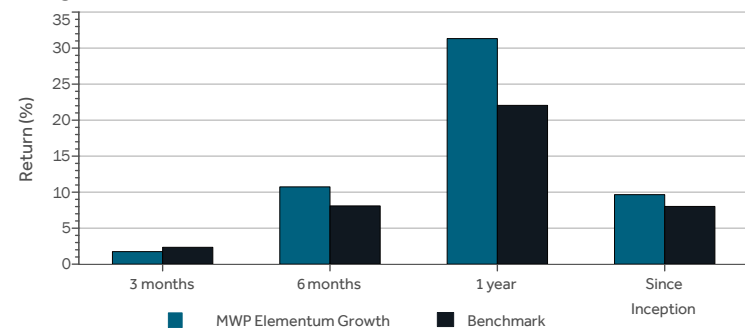

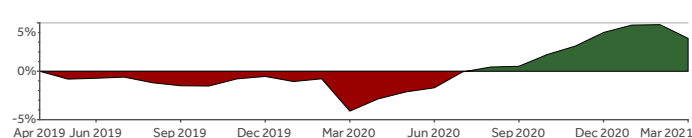

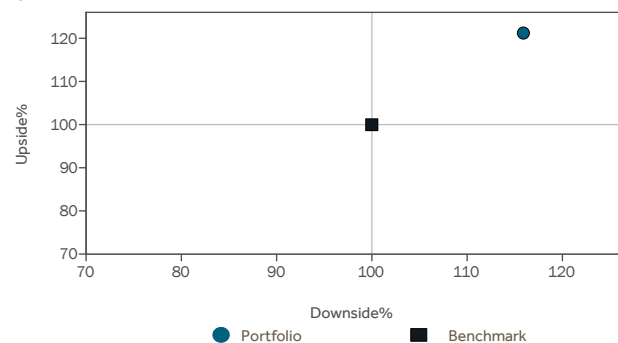


Cumulative Excess Return vs. Market Benchmark

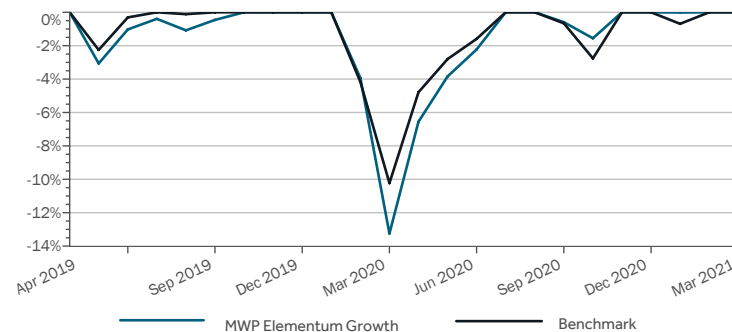
